# General Provisions

## Admission for study

Admission for doctoral studies may be granted to persons providing evidence of successful completion of a course (diploma, master level) at a recognised university or higher education institution in one of the following areas of study:

- human, dental or veterinary medicine
- pharmacy
- diploma and/or master's courses in natural sciences
- diploma and/or master's courses relating to health sciences.

Overall, evidence of academic studies of at least five years or 300 ECTS credits must be provided.

## Application/process

Receipt of the application shall be confirmed in writing following a review of the admission requirements. Applicants accepted for courses of study will be notified immediately after the completion of the selection procedure. If there are insufficient applicants, the UFL reserves the right not to implement the study programme. In this case, payments already made will be reimbursed.

## Programme changes

The UFL reserves the right to make changes with regard to the structure and content of the study programme, as well as the selection and employment of lecturers.

## Tuition fee

The tuition fee is CHF 27,750.00 (CHF 1,250.00 registration fee and CHF 26,500.00 for eight semesters). It will be invoiced as follows:

- The registration fee of CHF 1,250.00 will be invoiced once only following delivery of confirmation of definitive acceptance for study.
- For semesters 1 – 4, CHF 6,250.00 will in each case be invoiced prior to the beginning of the respective semester.
- For semesters 5 – 8, CHF 375.00 will in each case be invoiced prior to the beginning of the respective semester.

The relevant invoices, together with terms of payment, will in each case be sent in a timely manner. Fees will also fall due even if a participant admitted into the study programme fails to participate in it or discontinues studies prematurely.

## Fee on extension of period of study

For an extension of the period of study beyond the eight semesters (i.e. from the 9th semester up until the time of submission of the dissertation), a fee of CHF 1,000.00 for each additional semester shall fall due.

## Deregistration

A student who without reasonable excuse fails to attend the course of study may be deregistered by the UFL after a written warning. In the event of deregistration, the tuition fees for each semester commenced shall be owed in full. If a student wishes to discontinue his programme of study prematurely, he shall apply for deregistration in writing at the latest 30 days prior to the commencement of the semester.

## Liability

Students are responsible for their own insurance. The UFL accepts no liability in the event of the absence of, or insufficient, insurance cover.

## Legal venue

The legal venue is Vaduz and the location for the fulfilment of contractual obligations is Triesen. Liechtenstein law is applicable.
